

FilmL.A. Neighborhood eNotification Program Terms of Use

The Neighborhood eNotification Program ("Program") is a free service offered by FilmL.A., Inc. ("FilmL.A."). These Terms of Use (the "Terms"), as set forth below, detail what information FilmL.A. will and will not provide through the program, and also what restrictions and limitations FilmL.A. places on use of information shared with program participants.

Program Overview

At FilmL.A., we believe neighborhood notification is vital to ensure on-location production can occur smoothly. Because all on-location filming can have an affect on nearby residents and businesses, community stakeholders deserve to be well informed about upcoming filming before film trucks roll into their neighborhoods.

In addition to the paper Notices of Filming that we distribute within local communities, FilmL.A. launched an eNotification Program in 2006, allowing registered program participants in select area neighborhoods to opt-in and receive supplementary Notices of Filming ("eNotices") by email.

Program Registration

FilmL.A. offers all visitors to its website the ability to register for the eNotification program. At registration, participants are obligated to provide FilmL.A. with an email address, and certify the accuracy of this information by their acceptance of these Terms of Use.

Per the terms of FilmL.A.'s Privacy Policy, participants' email addresses will be kept confidential and used only for the purposes of supplying supplemental eNotices to current participants. Each eNotice distributed by FilmL.A. will also include information instructing participants on how to withdraw from the program.

During registration, and at any time thereafter, participants may opt-in to receive eNotices for <u>no</u> <u>more than three</u> different geographically-defined program areas per registered email address.

Participants may only register to receive eNotices in program areas in which they hold legitimate neighborhood interests. For example, participants are encouraged to opt-in to areas in which they and their family members live, work, worship, or attend school.

Under no circumstances may subscribers opt-in to more than three program areas, nor may subscribers register multiple email addresses in order to circumvent the three area restriction.

Participants also may not register for the program for the specific purpose of commercially exploiting program information for financial gain. Participants may not redistribute, republish or create derivative works using information shared through the program.

Violation of any of these registration policies will be grounds for removal from the program. FilmL.A. has sole discretion to determine which, if any, subscribers are in violation of these Terms.

Frequency of eNotices

The number of eNotices distributed to participant will depend on the number of permitted onlocation filming events that occur within each participant's choice of geographically-defined program areas.

Accuracy of eNotices

Because eNotices are often distributed before film permit terms are finalized, FilmL.A. cannot and does not guarantee that the information contained in any eNotice is whole, complete or error-free.

Should any eNotice distributed through the program be found to contain an error, FilmL.A. may distribute a corrected eNotice, but is under no obligation to do so.

Program Limitations

By becoming a program participant, you acknowledge these limitations and agree that neither FilmL.A., nor its predecessors, successors, partners, affiliates, directors, officers, employees, agents or representatives shall be liable for any reason for damages of any nature (including special, incidental, compensatory, consequential or punitive) to any individual or entity, or to the predecessors, successors, affiliates, partners, directors, employees or heirs of any such individual or entity, who uses or relies on information from the program for any purpose whatsoever. FilmL.A. may also amend or modify these Terms of Use, and may discontinue the program at any time.
